Agency Network Updates

Higher Item Limits

We are happy to announce that, after working with our Operations Team, item limits for some of the available products on our online ordering menu have been updated to reflect the increased community need.

This means that partner agencies will see higher available quantities on some key items on Agency Express 3 (AE3). Our Food Sourcing Director will continue to moderate the available quantities as we source more products and increase them whenever possible.

Winter Bonus Product

As another special boon to our Partner Agency Network, and due to our increased donations and purchasing during the lapse in SNAP funding, our Agency Network Team will be adding 20% to partner orders starting this week, continuing through January. We hope that this temporary increase in quantities will provide additional support and relief to our community.

We are deeply thankful for the remarkable efforts and dedication from the community and Partner Agency Network during the government shutdown and lapse in CalFresh/SNAP funding. As many in our

community were affected by the shutdown, Second Harvest hosted multiple mass food distributions at county buildings, school locations, the Santa Cruz Boardwalk, and the Santa Cruz Fairgrounds. Over 3,500 households were served at these extraordinary distributions, 2,000 of which were at our drive-through Fairgrounds distribution.
